

VentureNet Iowa PRIVACY POLICY

Introduction

VentureNet Iowa (VNI) is committed to protecting your privacy. This Privacy Policy is intended to clearly explain VNI's privacy practices for collaborative services and the Angelsoft platform. It includes what type of personal information is collected, how that information is used, and with whom the information may be shared with. VNI reserves the right to amend this Privacy Policy at any time. Please check back frequently in order to view any changes made to this policy.

Identification of Confidential and Proprietary Information

The identification of confidential and proprietary information is based on the owner's discretion. VNI waives all responsibility for identify information as confidential and proprietary.

Submitting Nonproprietary Information

When you set up your account with VNI, you will be required to enter nonproprietary information about your company in the VNI Angelsoft Group Application. Do not provide confidential and proprietary information in your Application. Your application will be posted on your company's Deal Page and may be viewed by VNI's collaborative resources.

Submitting Confidential and Proprietary Information

Confidential and proprietary information must be submitted to VNI as an attached document to the Application. VNI will detach the Confidential Documents from the Deal Page and store the documents in VNI's confidential files.

**** If the Owner wishes to disclose Confidential Information to VNI after the Application has been submitted, the Owner must contact an administrative member and make arrangements to send the Confidential Information via email to jenny@venturenetiowa.com. The administrative member will then detach the Confidential Information from the email and store the documents in VNI's confidential files.****

VNI agrees not to disclose Confidential Information without the prior written consent of the Owner. All such disclosures shall be in writing. VNI is not responsible for any disclosures and or use of information by third parties to this agreement. VNI is not responsible or liable for the actions or omissions of any third party the Owner consents to release information to. As a condition to the submission of your application, you hereby waive and release any and all claims and causes of action that you might have against VNI relating to the submission and reviewing of materials made available to third parties.

Return of Confidential and Proprietary Information

Confidential information furnished in tangible form shall not be duplicated by VNI except for purposes of this Agreement. Upon the request of the Owner, VNI shall return all confidential information received in written or tangible form, including copies, or reproductions or other media containing such confidential information, within ten (10) days of such request.

VNI has implemented this Privacy Policy to prevent the unauthorized release of or access to personal information. Please be advised that the confidentiality of any communication or material transmitted to or from VNI via Internet cannot be guaranteed. Accordingly, VNI is not responsible for the security of information transmitted via the Internet.

This Privacy Policy only applies to VNI and members of the VNI Angelsoft Group. It does not apply to interactions you have with other Angelsoft Groups. The administrator of each Angelsoft Group has the ability to share information you submit to the Angelsoft platform.
